

11. Consultant Status Report Effort since last meeting (October 12th)

- ▼ TWDB sent draft projections methodology for irrigation, manufacturing, and steam-electric demands
 - Methodology was reviewed
 - Population and Demand Committee meeting held to discuss responding comments (December 5, 2016)
 - Comment letter prepared and sent to TWDB (posted on Region K website)
- ▼ TWDB sent draft population, municipal demand, and mining demand projections to the regions
 - Currently reviewing projections and updating WUG addresses for mailouts
- Additional coordination with TWDB and others

11. Consultant Status Report Effort since last meeting (October 12th)

- ▼ Summary of Region K comments on TWDB Projections Methodology:
 - 1. Concerns regarding using the most recent 5-year water use as the baseline demand for irrigation
 - 2. Questions on how the proposed methodology for projecting irrigation demands in areas with significant groundwater availability decline would be applied
 - 3. Concerns with keeping manufacturing demands constant after 2030
 - 4. Concerns with using "average" year baseline steam-electric demand instead of a "high use" year steam-electric demand.
 - 5. Requested clarity regarding steam-electric projected water use shown in Table 4.5 of the methodology document

▼ Grant Application for remaining 5th cycle funding

Current funding for Region K: \$109,356


Additional committed funds: \$313,844

Future anticipated appropriations: \$470,765

Total 5th cycle funds: \$893,965

- Grant application is due to TWDB by February 21, 2017
- Likely that most tasks will be partially or fully funded by the committed funds
- The Water Management Strategy Evaluation task will require a specific Scope of Work to be written and approved before work can begin

- ▼ Emphasis of TWDB effort on population and municipal demand projections involved transition from political boundaries to utility service area boundaries
- ▼ Municipal demands generally utilized the base gallons per capita daily (GPCD) volumes from the 2017 State Water Plan
- ▼ For new water user groups (WUGs), the 2011 or 2014 GPCD volumes were used
- ▼ Regions may request limited changes to the draft projections based on the transition from political boundaries to utility boundaries and on relevant changed conditions that have occurred since the development of the projections used in the 2016 regional water plans

▼ Mining demand totals by county have not changed from the 2016 Region K Plan numbers.

- ▼ Path forward for draft projections:
 - Posting draft projections on Region K website for review
 - Sending notices to municipal WUGs letting them know about the draft projections and asking for feedback
 - Send similar notices to each county regarding County-Other and nonmunicipal demands
 - Coordinate as needed with TWDB regarding municipal WUGs that were requested, but not included in draft projections
 - Work with Population and Demand Committee to evaluate projections and develop any applicable projection revisions to request to TWDB
 - Opportunities for modifying region and county population totals are limited
 - Review applicable 5th cycle public input items for consideration
 - Bring potential revisions to the entire RWPG for review and approval before submitting to TWDB for consideration
