





 - Response: Additional language has been added to confirm that local surface water supplies were developed for drought of record conditions.
 - Tables 3.12, 3.18, and 3.19. Please include all MAG values (even if zero) for the following aquifer/county/basins: Carrizo-Wilcox/Fayette/Lavaca, Queen City/Fayette/Lavaca, and Sparta/Fayette/Lavaca.
 - Response: Tables 3.12, 3.18, and 3.19 were edited to include the zero volume MAG values for the Lavaca Basin within Fayette County, as reflected in the GMA-12 report for GAM Run 17-030.

 - Section 7.4. Please confirm whether the entities evaluated for emergency responses to local drought conditions or loss of municipal supply were assumed to have 180 days or less of remaining supply.
 - Response: A statement was added confirming that emergency response was evaluated for 180 days or less of remaining supply.
